Synthetic Drug Analysis Test No. 23-5041 Summary Report

Each sample pack consisted of two questioned samples containing powdered substances. Participants were requested to analyze these samples for the presence of synthetic drugs. Data were returned from 94 participants and are compiled into the following tables:

This report contains the data received from the participants in this test. Since these participants are located in many countries around the world, and it is their option how the samples are to be used (e.g., training exercise, known or blind proficiency testing, research and development of new techniques, etc.), the results compiled in the Summary Report are not intended to be an overview of the quality of work performed in the profession and cannot be interpreted as such. The Summary Comments are included for the benefit of participants to assist with maintaining or enhancing the quality of their results. These comments are not intended to reflect the general state of the art within the profession.

Participant results are reported using a randomly assigned "WebCode". This code maintains participant's anonymity, provides linking of the various report sections, and will change with every report.

Manufacturer's Information

Each sample pack consisted of two items. Item 1 contained approximately 200 mg of 18% N,N-Dimethyltryptamine (DMT). Item 2 contained approximately 250 mg of cornstarch. N,N-Dimethyltryptamine is a Schedule I controlled substance in the United States.

SAMPLE PREPARATION: Prior to production, the appropriate amount of N,N-Dimethyltryptamine and cornstarch for Item 1 were combined and thoroughly mixed to ensure homogeneity.

ITEM 1 (PREPARATION): Approximately 200 mg of 18% N,N-Dimethyltryptamine was weighed out and deposited into a glassine bag, which was folded and secured with a label. The folded glassine bag was placed into a small zip top bag, which was heat sealed and then placed into a pre-labeled envelope.

ITEM 2 (PREPARATION): Approximately 250 mg of cornstarch was weighed out and deposited into a glassine bag, which was folded and secured with a label. The folded glassine bag was placed into a small zip top bag, which was heat sealed and then placed into a pre-labeled envelope.

SAMPLE PACK ASSEMBLY: One of each of the Item 1 and Item 2 envelopes were placed into a larger pre-labeled sample pack envelope.

VERIFICATION: The above substances were identified by predistribution laboratories, who used the following combined list of techniques: GC-MS, FTIR, TLC, Color Tests, TruNarc Raman, UV, GC.

Summary Comments

This test was designed to allow participants to assess their proficiency in the qualitative analysis of questioned samples that may contain synthetic substances. Item 1 consisted of approximately 200 mg of 18% N,N-Dimethyltryptamine (DMT). Item 2 consisted of approximately 250 mg of cornstarch. In the United States, N,N-Dimethyltryptamine is a Schedule I controlled substance (See Manufacturer's Information for preparation details). It is a psychadelic compound bearing the tryptamine substructure. While DMT is a naturally occuring substance present in many plants, tryptamines can also be synthetically produced in clandestine labs.

For Item 1, 79 of the 94 participants reported the synthetic drug group "tryptamine" while 15 reported that a synthetic substance was detected/identified but did not specify a group. All 94 participants that reported the presence of a synthetic drug further identified/detected N,N-Dimethyltryptamine (DMT). All 94 participants reported that no synthetic substances were identified for Item 2. The most commonly reported examination methods were GC/MS, color tests, and FTIR.
