Mobile Digital Evidence - Android Analysis Test No. 24-5550 Summary Report

Participants were provided with data yielded from an extraction of a smartphone. They were asked to examine the extracted data and answer scenario-based questions utilizing their own tools and methods. Data were returned from 111 participants and are compiled in the following tables:

This report contains the data received from the participants in this test. Since these participants are located in many countries around the world, and it is their option how the samples are to be used (e.g., training exercise, known or blind proficiency testing, research and development of new techniques, etc.), the results compiled in the Summary Report are not intended to be an overview of the quality of work performed in the profession and cannot be interpreted as such. The Summary Comments are included for the benefit of participants to assist with maintaining or enhancing the quality of their results. These comments are not intended to reflect the general state of the art within the profession.

Manufacturer's Information

The Mobile Digital Evidence – Android Analysis test consisted of evidence data acquired from a smartphone. Participants were asked to examine the extracted data pertaining to a simulated scenario using their own tools and methods.

SAMPLE PREPARATION/VALIDATION

A scripted scenario based upon a death investigation case was created to generate user data on the evidence Android device. The execution of the scripted crime took place between 25 November 2023 and 14 January 2024. A Google Pixel 5 smartphone was used to perform the activities and generate the intended artifacts.

The phone data was acquired via a file system extraction of the smartphone using Cellebrite software and compiled into a zip archive. This file was uploaded to the CTS Portal for participants to download. A MD5 checksum was calculated for the file to generate a unique hash value that allows participants to validate the successful download of the file.

The validation stage consisted of the examination of the phone data using various tools including Cellebrite PA 7.66, Android debug bridge 34.0.5, Autopsy 4.21.0, 7-zip 19, Exiftool 12.05, Windows Powershell 5.1.19041.3930 and DB Browser for SQLite version 3.12.2.

VERIFICATION: Results from the predistribution laboratories were reviewed and certain questions were rephrased as necessary. Several forensic software tools were utilized during the validation of this test. CTS does not endorse any particular tools.

PLEASE NOTE: Questions marked with asterisks (**) did not show a clear consensus during preliminary review of the participants' responses. Further information and discussion will be available in the final summary report.

SCENARIO PROVIDED TO PARTICIPANTS

The subject phone was discovered near the body of an unidentified woman found deceased at the bottom of a staircase. The device was submitted to your lab to determine, to the extent possible, the woman's identity and the events before her death.

Summary Comments

The purpose of this Mobile Digital Evidence Test is to allow participants to evaluate their proficiency in analyzing digital artifacts using their own tools and methods. The participants were provided with a scripted scenario, the data extracted from a smartphone, and a series of questions related to the extracted data. Refer to the Manufacturer's Information for preparation details.

The participants were requested to analyze various digital artifacts including: image details, phone and network settings, native and third-party applications, communications, web browser history, and Geo-Location information.

A total of 111 participants returned results for this test. Of the 32 questions that comprised this test, two questions did not achieve a consensus response, questions #13 and #29. For question #13, participants were asked to locate and report the last activity date for the Tinder app. Approximately 33% of responding participants reported the Manufacturer's response of 2024-01-13, while another 52% reported 2024-01-14. For question #29, participants were asked to identify the last location the user searched in the Google maps app. Approximately 59% of responding participants reported the Manufacturer's response of "The Exorcist Stairs" while 26% reported a Glebe Rd address in Arlington VA.

Detailed explanations and screenshots of the Manufacturer's responses can be found within Table 1 under the "Manufacturer's Response Explanation" section for each question.

Participants are encouraged to follow their laboratory's policies and procedures when evaluating their responses to these proficiency test questions.






































Response Illustration:


