Mobile Digital Evidence - Android Analysis Test No. 25-5550 Summary Report

Each participant was provided with data yielded from an extraction of a smartphone, which they were asked to examine the extracted data and answer scenario-based questions utilizing their own tools and methods. Data were returned from 95 participants and are compiled in the following tables:

This report contains the data received from the participants in this test. Since these participants are located in many countries around the world, and it is their option how the samples are to be used (e.g., training exercise, known or blind proficiency testing, research and development of new techniques, etc.), the results compiled in the Summary Report are not intended to be an overview of the quality of work performed in the profession and cannot be interpreted as such. The Summary Comments are included for the benefit of participants to assist with maintaining or enhancing the quality of their results. These comments are not intended to reflect the general state of the art within the profession.

Manufacturer's Information

The Mobile Digital Evidence – Android Analysis test consisted of evidence data acquired from a smartphone. Participants were asked to examine the extracted data pertaining to a simulated scenario using their own tools and methods.

SAMPLE PREPARATION

A scripted scenario based upon an identity fraud case was created to generate user data on the evidence Android device. The execution of the scripted crime took place between 5 December 2024 and 31 December 2024. An Android Google Pixel 5 smartphone was used to perform the activities and generate the intended artifacts.

The phone data was acquired via a file system extraction of the smartphone using Cellebrite software and compiled into a zip archive. Following sample validation, the file was uploaded to the CTS Portal for download by test participants. A MD5 digest (cryptographic checksum, or 'hash') was calculated for the compressed data and provided to participants to enable validation of a successful download of the file(s).

VERIFICATION: Predistribution results were consistent with each other and the manufacturer's preparation information. The combination of internal test validation and the responses received from predistribution testing structured the final questions utilized in this test. The following list of tools were utilized in the validation of this test: Cellebrite PA 7.70.0.5, Cellebrite Inseyets 10.4.1.2071, Android debug bridge 35.0.2-12147458, Autopsy Forensic 4.21.0, 7-zip 24.09, Exiftool 12.65, Windows Powershell 5.1.22621.4391, DB Browser for SQLite 3.12.2, Xways 21.0, Notepad++ 8.7.1, and sha256deep 4.4. CTS does not endorse any particular tools.

SCENARIO PROVIDED TO PARTICIPANTS

The owner of the subject phone, Taylor Thomas, is seeking employment. Thomas applies to several positions on sites including Monster.com, Indeed.com, local Craigslist listings, and others. Taylor receives several offers, and text messages for job opportunities, one or more of which are from scammers requesting additional identifying information from Taylor, who is subsequently a victim of identity fraud. After being defrauded, Taylor turns the phone over to law enforcement for extraction and investigation to determine the identity of the fraudsters.

Summary Comments

The purpose of this Mobile Digital Evidence Test is to allow participants to evaluate their proficiency in analyzing digital artifacts using their own tools and methods. The participants were provided with a scripted scenario, the data extracted from a smartphone, and a series of questions related to the extracted data. Refer to the Manufacturer's Information for preparation details.

The participants were asked to analyze various digital artifacts, including image details, phone and network settings, native and third-party applications, communications, web browser history, and geolocation information.

A total of 95 participants returned results for this test. All 32 examination questions achieved consensus.

Detailed explanations and screenshots of the Manufacturer's responses can be found within Table 1 under the "Manufacturer's Response Explanation" section for each question.

Participants are encouraged to follow their laboratory's policies and procedures when evaluating their responses to these proficiency test questions.


































































Cellebrite Metadata view of PXL 20241214 221132312.jpg

6MPAV3	Question 15: Upon initial review, Cellebrite Physical Analyzer displays the values "task" and "taskrabbit" as search terms for the date/time 12/30/2024 (30 December 2024) 07:54:07 AM. However, the Chrome history database only displays the search term "taskrabbit." While looking at the artifact in Magnet AXIOM, noticed the Search Term attribute was "taskrabbit" and the Original Search Query attribute was "task." The Search Term artifact is defined by Magnet AXIOM as "the string that was searched" and the Original Search Query is defined as "the query at the start of the search session." To clarify, reached out to Magnet Technical support. They advised if "task" is showing as the original search query, it indicates that "task" was the first term entered at the start of the session, which helps track the user's initial intent. The first term entered doesn't necessarily mean it was searched. It just indicates the first term that was typed in.
8WPGQT	For question 26: Physical Analyzer 7.70, Physical Analyzer 10.5, and Axiom 8.9 did not decode the content of the Keep notes. Oxygen Forensic 16.3.1 did decode the data, but did not associate the text to the body of the notes. I would be interested in finding out what software you used to show the fully decoded note with name and body of the note.
BCNVEC	Question Nr 15: 2 results appeared for the same date and time: 1. task, 2. taskrabbit
CC3GND	Practitioner queried on Q24 - they advised that PA did not process SHA256, and Axiom failed to process SHA256 despite two attempts with the option selected.
D22D2V	Couldn't find any file related to the mentioned hashes from question 23 and 24.
FWVWDQ	question 32 has several instances of the image in question with location data. there are conflicting (-) coordinates in the position field between the different images
HVZPA6	Question 4- should be more specific. This seems to be asking about MSISDN from SIM Card, but doesn't specify. And given there is also a google voice number on the phone, people might answer this instead. Question 16- why doesn't this question end in "(Device local time)" like the others? Because technically this bookmark in UTC was added 01/01/25, not 12/31/24. Question 31, there is one original and 2 variants of this photograph. Are all three a correct answer? Also, question says photo has "\$30.55." That's not quite correct- it has "30.55" and "\$" in different font and color very far to the left. We may parse it and understand it as meaning "\$30.55" however that's not exactly what's present on the photo. At the very least would be more like "\$ 30.55".

JMDLDM	I was able to find answers for all of the questions, however several of the questions listed below do not fall within our laboratory's scope of reporting. This is more of a CT exam than a PT exam. Some of the fields that require only a number are not formatted so the value Not within laboratory's scope could be entered. Q13- We would not normally report just a hash to our customers unless specifically requested and our customers would not normally request just a hash. Any hash values calculated during the examination process would be included in our portable case reports on our findings disk. I was able to locate the the file received and described in the question, export it out and obtain a SHA-256 hash value. Q14 - We would not normally copy and paste the whole text message content on our report to the customer. We may summarize the content. The full message and related information would be provided in our portable case reports on our findings disk. I was able to locate the message described in the question and view its

contents. Q23 - This would not be a normal request from our customers, and we would not normally just report a hash value unless specifically requested. I was able to located the file as described in the question and verify the MD5 hash value and also obtain a SHA-256 hash value. Q24 - Our customers would not

normally request this from us in this manner and request a hash value. We would report files within the scope of the search authority and the associated information which would be included in our portable cases on our findings disk. Many of our tools do not by default calculate SHA256 hash values for files. I was able to use a tool which was able to hash all files in SHA256 and located the file in question. The file is an image related to a transit company. Q29 - We would not normally report this as absolute fact, due to the nature of Google voice numbers being virtual and not being tracked or identified like an MSISDN, determining this number by a specific file or database. I was able to find a number which appears to be the GVN for the user which was located in an snapshot of an unfinished resume as well as Google email notifications. This may be provided on a findings disk to the customer as an investigative lead in which a search warrant or production of records may be obtained for that information. This field is not formatted properly to allow users to type in Not within laboratory's scope. The numbers 123456789 were entered instead of not within laboratory's scope. Q30 - We would not normally provide a detailed or verbatim description of the audio file, and just provide the file on the findings disk. We may provide a brief description of the file and what it appears to be depending on the request and search authority. I was able to locate the file in this case it appears to be a recording of a dog barking. Q31 - There are at least two possible answers to this question. There are at least two photos captured by this device matching the description in the question with metadata showing the Pixel 5. One is a standard photograph and one is a live photograph. I was able to locate two files and hashed them in SHA-256. Q32 - In this case our forensic tool provided the GPS coordinates in the format requested, however if our forensic tool did not provide this information in the format requested it would be out of scope as we will not convert the reported format.

- KPHCHG Various questions were able to be answered due to the data not being parsed / viewable. Several digital forensic platforms were used, with the same results. Q20.The device user has Maggie MARSH listed as a contact, but records display no relevant call log data (number of times contacted 0). Q24. A search of a file with the provided SHA256 hash value resulted in zero (nil) results via the search function in Magnet AXIOM Complete v8.4.0. The SHA256 value was loaded into a Hash calc tool. The path of the file is D:\Pixel\data\data\com.google.android.gms\cache\image_manager_disk_cache\7e72104e4c5689a15c 65b52c3477d1936f6a530ec666f1f1d18472bffb984dc0.0 . I could not locate this data within AXIOM, however, I suspect this would be an cached image file of some description. Q26. Data not parsed / viewable. 3 x notes titled 'Sunday', displayed nil text. No Google Keep data visible in Cellebrite Physical Analyser. Q29. Google Mail address only taylortaylort99@gmail.com. No number seen. AXIOM displays Google Voice as an unsupported application.
- MWWY6G The following questions are outside the lab's scope and were intentionally left blank: 2, 12, 19, 20, 21, and 29.
- NMLWJG The database which shows the answer to question 14 shows that the message was actually received at 4:00:17 PM.
- QBK9HX Question 1 asks to provide the SHA-256 hash of Pixel5.tar._x000d_ I am unsure what the end of the file name "_x000d_" is asking for. Most of our forensic tools do not provide SHA-256 hash values making some of the questions difficult to answer. Question 31 Several versions of this image exist with different file names and hash values.
- UULM8E Question no. 24 is a little bit vague on what I should input.
- X28RQP Some of the questions (such as Question #29) were hard to answer. In fact, Question #29 wasn't able to be answered by any of the commercial forensic tools available for use within my lab. I had to used Cellebrite Physical Analyzer, Magnet AXIOM, and Oxygen Detective to answer all questions to the best of my ability.
- ZQ4DHN This test was solved by 11 expert personnel.
