



Latent Print Examination Test No. 15-517/518 Summary Report

This test was sent to 610 participants. Each sample pack contained either digitally produced photographs (15-517) or a DVD with digital images (15-518) of eleven latent prints and four sets of known finger and palm imprints. Participants were asked to compare these and report their findings. Data were returned from 509 participants, 342 for 15-517 and 167 for 15-518 (83% response rate) and are compiled into the following tables:

This report contains the data received from the participants in this test. Since these participants are located in many countries around the world, and it is their option how the samples are to be used (e.g., training exercise, known or blind proficiency testing, research and development of new techniques, etc.), the results compiled in the Summary Report are not intended to be an overview of the quality of work performed in the profession and cannot be interpreted as such. The Summary Comments are included for the benefit of participants to assist with maintaining or enhancing the quality of their results. These comments are not intended to reflect the general state of the art within the profession.

Participant results are reported using a randomly assigned "WebCode". This code maintains participant's anonymity, provides linking of the various report sections, and will change with every report.

Manufacturer's Information

Each sample pack contained digital images consisting of known finger and palm imprints of four individuals and eleven latent "crime scene prints". Each of the eleven latent prints was made by one of the individuals for whom inked imprints were provided.

SAMPLE PREPARATION-

All inked known fingerprints and lifted, powder-dusted latent prints were scanned directly into image editing software and assembled onto test templates. Background noise of each latent print was digitally reduced. The original deposition of a latent print may be minimally altered via cropping to remove ridge detail and increase comparison difficulty. The latent prints were then provided in 1X and 2X magnification examples.

VERIFICATION-

Prior to predistribution, the latent prints were analyzed and confirmed by an external advisor to present appropriate detail, clarity, and difficulty. The expected Identification responses were reported by the predistribution examiners.

SAMPLE PACK ASSEMBLY -

Once verification was complete and sample preparation was done, each photo set was placed into a pre-labeled sample pack envelope, sealed with evidence tape, and initialed with "CTS." Each DVD was checked to ensure all images were accessible.

Summary Comments

This test was designed to allow participants to assess their proficiency in the identification of latent finger and palm prints. Each of the eleven latent prints (Q1-Q11) was made by one of the four individuals for whom inked prints were provided (Items A-D) (Refer to the Manufacturer's Information for preparation details).

Of the 509 responding participants, 432 (85%) reported the expected eleven identifications. Consensus outliers are described below, with the types of outlying responses provided in parentheses following each description.

There were seventy-seven total participants who reported inconsistent results for one or more of the latents. Of this group, there were twenty participants who attributed a latent to a different finger or palm than that established by the consensus (Other Identifications). There were fifty-seven participants who did not identify a latent for which known prints were provided (Not Identified). Within those fifty-seven, one participant also attributed a latent to a different finger or palm than that established by the consensus (Not Identified and Other Identifications). Additionally, one other participant in those fifty-seven identified an individual, but marked "NI" for the finger selection; this response has been grouped with the "Not Identified" statistics. A majority of those that marked "Not Identified" did so for latent prints Q6 and Q11, with observations that these prints were the most challenging.
